Privacy Policy & Disclosure

At OFC we take privacy of our visitors extremely seriously. This Policy describes exactly how we treat visitor information we collect through our online or offline sources.

This Privacy Policy applies to current and former visitors to our website, in its latest updated version. By visiting and/or using our website, you agree to this Privacy Policy.

Information we collect:

Contact information: Whenever you choose to reach out to us using the Contact option on our website, we shall be collecting your Name and Email address (“**Personal Information**”).

Information Visitors post: Questions or comments submitted by visitors on The Thought Project may also be included as Personal Information depending on their nature.

Other information (Non-Personally Identifiable Information): If you use our website, we may collect information about your IP address and the browser you're using. We might look at what site you came from, duration of time spent on our website, pages accessed or what site you visit when you leave us. We might also collect the type of mobile device you are using, or the version of the operating system your computer or device is running.

Collection of Information:

Personally Identifiable Information (PII): All identifiable personal information, including but not limited to name, email address etc is collected directly from the visitors, with the consent of the visitors through Contact Forms.

Non Personally Identifiable Information (NPII): Unidentifiable information, that is information that cannot be used to indentify you, are collected using analytics tracking tools like Google Analytics, Google Webmaster etc for collecting information about your usage of our website and the duration spent on our website.

Use of Information:

Personally Identifiable Information: We would use your personal information including but not limited to your name and email address to reach out to you to address your question or query. We would be securely storing your personal information and may also reach out to you whenever in future opportunities related to your interests arise or for any other purpose you may expressly authorize us to reach out to you for.

Non-Personally Identifiable Information: Information gathered using Analytics tools would be used to understand which content generates more visitor traction and help us improve our work and website.

Sharing of information with third-parties:

One Future Collective does not and will not share personal information of its visitors with any third party for any marketing or promotional purposes, without prior permission.

One Future Collective may share your personal information for any non marketing or non promotional purpose with its subsidiary bodies or partner organizations.

In case One Future Collective is legally mandated to share Personally Identifiable Information or Non-Personally Identifiable Information with investigative and/or legal authorities in response to legal proceedings, OFC shall endeavor to inform you of the same but is not bound to do so.

Additionally, OFC may also share your Personal Information to a Third Party to protect and enforce our legal rights in the event that you violate the Site Terms of Service or any other guidelines or rules applicable to our website or services.
